**Do I win every time one my friends wins?**

No, you only win if your friend played after clicking on the link you sent him. If he plays by himself, you won't win, even if he wins.

**I already invited a friend on a previous prize and I invite him again: does it works if he wins?**

**ARTICLE 1: OBJECT**

The winner has 10 days after receiving the confirmation e-mail to send those identity documents. The winner will receive their prize within 30 days after our reception of the e-mail with their mail address.

If the winner doesn't ask for their prize within 30 days, no claim will be considered. The prize will be brought into play for another contest.

#### ARTICLE 5: RESPONSIBILITY AND RIGHTS OF THE ORGANISING COMPANY

Preliminary conditions

i) Failure, connexion issues, virus
